The more recent wave of health challenges significantly hampered my research contributions in 2019-2023, and their influence is likely to be evident in my professional record for many years to come. At present, I am functional, but remain under active medical surveillance, have not fully recovered, and have pending surgeries ahead. Nonetheless, I hope to remain resolute in overcoming these obstacles and pursuing my academic endeavours to the best of my abilities.
